## **Watershed Balanced Model**

## **Investment Objective**

The Watershed Balanced Model seeks to provide investors with capital growth over the medium to longer term (at least 5 years) and tax effective income through exposure to a diversified portfolio of assets.

The objective of the Watershed Balanced Model is to outperform the Financial Express Unit Trust Peer Group Multi Asset Balanced Index after costs.

## **Investment Strategy**

The Portfolio is an actively managed, diversified portfolio of securities across both growth assets such as Domestic and Global Shares, Property Trusts, Exchange Traded Funds and defensive assets such as cash and fixed interest securities. The portfolio will generally hold approximately 60% in growth assets and 40% in more defensive assets over time, but the mandate has deliberately broad target ranges allowing implementation of tactical asset allocation given our macro-economic views and expected asset class and sector returns.


#### The Portfolio is designed for investors who...
